Statement by Daniel Hirsch, President, Committee to Bridge the Gap Regarding Clinton Administration's Decision on Ward Valley Nuclear Waste Dump

The Colorado River weeps today. The Administration has sold the Colorado River down the river.

Not since John Muir's heart was broken by the loss of Hetch Hetchy has California's environment lost such an important battle. But all that was lost at Hetch Hetchy was a gorgeous valley; here we may well have polluted, for half a million years to come, the main water source for most of the Southwest.

When will this Administration learn that it cannot expect people to stand by it when it won't stand by its own word? It had promised it wouldn't transfer the land until the state court litigation was resolved and an evidentiary hearing held. It has now abrogated those commitments.

The Clinton Administration has today done itself great damage in Cal jfornia and in the environmental community nationally. It can partially redeem itself only if it imposes genuine, rigorous, binding, and enforceable conditions on the Ward Valley transfer. If it doesn't, its representatives will find an extremely frosty reception whenever they try to set foot here, asking their natural allies for help.

Take the tritium measurements immediately. Don't transfer the land unless the site passes those safety tests. Restrict the individual radionuclides to the amount the public was told in the Environment Impact Statement would go to the dump. Only by these actions can the Administration partially redeem itself for its actions today in breaking its commitments on Ward Valley.

All eyes will now be on Babbitt and Wilson as they negotiate conditions for the transfer. ~ Wilson says the NAS report is the best thing since sliced bread, but he refuses to commit in a binding and enforceable fashion to carry out all its recommendations, Wilson says the Environmental Impact Report is accurate and no more waste will go to the dump than disclosed therein, yet he refuses to be bound to the limits in the EW for individual radionuclides such as plutonium and cesium. He says he is convinced the facility is safe, yet refuses to take the tritium

measurements recommended by the NAS now, and refuses to agree to have the project not go forward if the site fails the tests. He promises to hold a hearing if he wants to increase the amount of wastes at the site, but he broke two previous promises to hold hearings, one to the State Senate and one to the Interior Department.

Interior's credibility has been severely strained as well. Secretary Babbitt promised he wouldn't transfer the land until there was an evidentiary hearing, with cross-examination and testimony by all sides. He broke that promise. He promised the land wouldn't transfer until the state litigation was over. He broke that promise too. People will be doubtless skeptical when he now says he will not transfer Ward Valley unless he receives binding, enforceable commitments to carry out the NAS committee's recommendations, including tritium testing, and cap the plutonium and other wastes in a binding, non-amendable fashion. We will be watching carefully to see if his word on this is any better than his word on the hearing and awaiting the court.

We will particularly watch closely to see if he requires the tritium testing be done now, before the transfer, and commits to not transfer the land if it fails that crucial safety test. And we will watch closely to see if he limits plutonium and other radionuclides such as cesium and strontium to the amounts in the EIR, and makes all conditions enforceable by the public and genuinely binding, not amendable later.

This nuclear dump will leak, as have all the other nuclear dumps operated by this company, US Ecology.

When that radioactive plume starts to migrate toward the Colorado--and migrate it will--it will have two names on it, Pete Wilson and Bruce Babbitt, with a single patron, the nuclear industry. Other Governors and Interior Secretaries have mountains named after them, to commemorate their conservation work. This leaking radioactive dump, and all the cancers it will produce, will be the perpetual memorial for the strange bedfellows Wilson and Babbitt, who put political expediency above moral obligation to future generations.

Either Interior and Wilson were lying when they said in the EIS that was how much would be dumped, in which case it should be redone; or if they were telling the iruth, they should put their money where their mouths are and commit, in binding fashion to no more plutonium, cesium, strontium, or the other radionuclides than they said in the EIS. You can't have it both ways; either you lied in the EIS or you told the truth. If true, make it binding, unchangeable, and publicly enforceable.

Hundreds of generations to come will curse this day, and the men who put political convenience over moral obligation to the future."

President Clinton, Vice-President Gore and Secretary Babbitt have all repeatedly committed that they would not transfer the land for a radioactive waste dump at Ward Valley until pending state court litigation was resolved and an evidentiary hearing was held. Transferring the land in violation of that promise puts the profits of the nuclear power industry ahead of citizens' health, safety and public participation rights."
